## 2010 Linton Freedom Festival

**Instructions: Please read the below carefully. Sign, date and return this form with your Registration Form.**

1. The 2010 Linton Freedom Festival's Marketplace will be held on Friday, July 2, 2010, thru Sunday, July 4, 2010. Hours will be 5:00 pm to 10:00 pm on Friday, 1:00 to 10:00 pm on Saturday and 1:00 pm to 9:00 pm on Sunday. All vendor Participants are required to participate for the three days.
2. **ATTENTION, ATTENTION, ATTENTION – DEADLINE FOR APPLICATION IS MONDAY, JUNE 21, 2010.**
3. Set-Up is on Friday, July 2 beginning at 11:00 am. Vendors **MUST** arrive in sufficient time to completely set-up for opening of show. A Festival Committee Member will be on hand at 15 minutes prior to posted opening time on Saturday and Sunday to open the building for inside vendors. A Festival Committee Member, at the designated closing time, will secure the building each evening. Tear Down will begin at 9:00 pm on July 4. **Inside Vendors must have tear down completed by 10:30 pm.**
4. The carnival **will be** conducted the same time as the Marketplace.
5. Electricity is available. Please specify the items you will be using that require electricity. You **must** provide your own extension cord, maximum 200 feet. Electricity provided will be 110 volts, 15 amps, unless you request arrangements and have them pre-approved. **Vendors cannot wire directly to the electric hook-up stations; you must use an extension cord.**
6. Outside Vendors must furnish own equipment. Committee will furnish space only. Inside Vendors will be provided one (1) 8' table and two (2) chairs.
7. You must keep your area clean. Pets are restricted to vendor's booth space.
8. The committee reserves the RIGHT to disapprove specific products or services offered for sale by the vendor. Vendors are only allowed to sell their products and or services within their designated booth space.
9. The committee, in order to best benefit the festival and vendors, will pre-assign spaces.
10. The committee reserves the right to approve or deny the participation of any applicant, if denied before the show begins on July 2, the fee will be returned in full.
11. There will be a \$20.00 service fee associated with any returned checks.
12. The Committee reserves the RIGHT to ask a participant to leave without a refund, if a DISAGREEMENT results over the location of booth space or the abuse of the original agreement.
13. Vehicles will not be allowed on/at vendors booth space except during initial set-up and teardown. Absolutely **no camping** will be allowed on/at vendors booth space. **No cargo trailers or RV's will be allowed on/at Vendor's booth space.** The festival will be providing security each night. Over night sleeping is permitted for outside vendors inside their booth space. **No public showers are available on site.**
